My name is David d. Whitson, I received your address from Dark eyes a very close friend of mine, Dark eyes and I are incarcerated here at the Ventress Corr. Facility located in Barbour County Ala. I've been here at Ventress approximately 1 1/2 years and since my stay I have observed officers physically and verbally threatening and/or beating at less 2 to 3 prisoners per month which this Warden J.C. Giles, and his Administrative Staff ratify brutal ASSAULTS by their officers upon inmates.

Dark eyes, informed me that you may be of grateful support in helping him, I and others here with the injustice inside Corruption of these officers repeated brutal ASSAULTS upon prisoners here at this facility. I am a strong supporter against officers brutal injustice inside the State Correctional Facility due to the fact, I have been physically assaulted twice by officers within the past 18 years of my incarceration. Thank God I have NOT been written a falsified disciplinary report like so many other inmates here in order for officers involved to conspire together attempting to cover up their unprofessional misconduct actions.

Sherry, please find enclosed these very important documents that (Dark eyes) Al ██████; and I are mailing to you because this institution has a bad habit of mail tampering opening outgoing mail intercepting anything that can expose their misconduct actions. Please forward these important documents to Montgomery, the correct mailing address(es) are on the front top left hand cover.

Dark eyes, told me to inform you that he will be writing you as soon as he receive some stamp because he has some more very important papers to mail you.

I Tommy Adams a.i.s.# 133644, I, m incarcerated here at the ventress correctional facility P.O. box 767 Clayton, Ala. 36016 . I, m over twenty - one years of age and do depose and say that the following statement is true and correct and made of my own free will, i was not threaten, promised or coerced.

I tommy adams 133644, arrived here at ventress facility on november 23.2004; since my stay here at this drug treatment facility i have been placed in treatment dormitories several times unvoluntarily asigned to beds that i was [not] apart of these treatment programs wasting up hard working tex payers money. The ventress i.c.s., bed asignment office asigned me to dorms in the following order " 7-A-32 sap dorm non-participated in treatment"; 9-A-51; 9-A-32 ; 7-A-20 again sap dorm non-participated in treatment for (2)weeks ; 8-B crime bill dorm for 1^{1/2} half months again non - participated in treatment; 7-B-29 sap dorm again which this time i took sap and completed the program on August 5th.2005, because my classification spcialest _____, informed me that she would transfer me upon completion if i complete this program. Afterwards i was moved again in 8-A-15 T.C., treatment dorm for 1-in a half weeks which i was [not] in aftercare nor participated in t.c., treatment. I was force to take up needed treatment bed space due to the fact Mr. Marburn, the drug treatment coordinator and ventress administrative staff kept putting me and other inmates that has completed and/or refuse these programs back in the same treatment dorms together with inmates that are in treatment.

Governor , myself like numerous other prisoners here are only taken up needed treatment bed space space from others which warden J.C. Giles, is very aware of this situation. I request that you please order Dr. Cavanaugh, the drug treatment administrator to personally come to ventress treatment facility and conduct a prompt investigation into the treatment violations, and inmates whitsons 152350, complaint.

REQUEST SOUGH

Request that you investigate Mr.Marburn,drug treatment coordinator and his staff,for housing non - treatment prisoners together in frug treatment dormitories with inmates that are participating in treatment ; for not checking inmates institutional jackets before moving prisoners that has prior completed treatment into these treatment dorms taken up needed bed space. Request that you investigate the treatment counselors/instructors for not teaching these treatment programs. Request that they are investigation for abuse of fundings also refusing to give inmates their funded treatment books and/or material after completion of these programs ; for rejecting prisoners out of programs for frivolous reasons such as other inmates heresay.

Investigate counselors/instructors for fraternizing with prisoners,and last request that reprimand actions are enforced upon all instructors/counselors and Mr.Marburn for any violations found within your investigation conducted, Request that a copy of your report is forwarded to the governors office c/o.Bob Riley for further actions taken due to abuse of any type fundings.

Thus,due to the fact i have completed my required treatment here i request immediately transfer from ventress treatment facility due to my health and safety of filing this complaint,and to avoid any type physical and/or verbal [retaliation].

I'm Over twenty-one years of Age and do depose and say that the following statement is true and correct and made of my own free Will, I was not threatened, promise or Coerced.

To whom it may Concern; governor Bob Riley or Dr. Caranough,
I Danny franklin # 213341, Arrived here at Ventress treatment facility on May 10th 2005, I was placed in dormitory 10-A-55 upon my arrival and later moved to dormitory 8A11 which is the T.C. treatment dorm. I have not sign up for this program or Volunteer for such a program, I have observed while in 8A, that the inmates are teaching inmates instead of the Counselors which are paid to instruct these treatment programs. Also I have observed there are numerous other inmates like myself that are in these treatment dormitories Not assigned to any program but only taken up needed treatment bed space from other prisoners that are required and/or Court ordered to take those programs. I further observed that after inmates Complete these treatment programs they are forced to remain here at Ventress a year or more later place in and out of treatment dormitories with inmates that are assigned in treatment classe(s)

What is not understood is why treatment programs here at Ventress are funded for inmates that has prior Completed them, but placed back in programs without any type relaps taken up needed bed space from others that are required to take the programs, which Counselor/instructors have each bed fill indicating each individual inmate has Volunteer for the treatment program.

Request that your department Conduct a prompt Carefull investigation here at the Ventress Corr. Facility upon the drug treatment Coordinator - Mr. Marburn and staff, for abuse of fundings; for housing prisoners together in treatment dormitories that are not apart of these treatment programs; for refusing inmates that has Completed these treatment programs their funded books and/or Material.

Request that the instructors are investigated for not teaching and/or instructing the Classe(s) but allowing inmates without any type degree teach the programs.

Request that a Copy of Dr. Cavanaugh's investigation report is prompt Forwarded to the governor's office for further investigation with reprimand actions taken against any an all Ventress administration for any type Violations. furthermore, request a transfer from the Ventress treatment facility due to the facts I have Completed (SAP) prior to arriving here at ventress, and to avoid any type retaliation do to the Pillag of my grievance.

I david d.whitson 152350,I,m incarcerated here at the ventress correctional facility P.O. BOX 767 Clayton,Ala.36016 I,m over twenty -one years of age and do depose and say that the following statement is true and correct and made of my own free will. I was not threaten.promise or coerced.

I prisoner david d.whitson 152350 arrived here at ventress treatment facility which is a drug treatment facility on August 17th.2004, on a warden to warden switch out from north ala hamilton A & I center to ventress because the A & I medical center needed bed space for a sick inmate arriving from ventress facility prior to my arrival here i had completed the (sap) drug treatment program required which documantation verification is listed in my D.O.C. institutional jacket.

Since my stay here i was put in for transfer on sept.23.04,which C.R.B.,approved oct.6.04.,for LCF.DCC.SCC.. On feb.3.05 put back in for transfer an approved feb.22.05., for LCF.ECF.BIB. an again march.1.05, re -recommended transfer an approved march 7.05, for ECC.BIB.SCC etc., any other level 4 facility. Unfortunately, i am still here at ventress treatment facility over a year and (4) months later still awaiting transfer taken up treatment bed space from other inmates i have no positive drug tests resulting while incarcerated, no disciplinaries at ventress,and have not relaps nor been out of prison. I have been forced to refuse sap here several times because Mr.Marburn drug treatment coordinator and his staff keep putting my name as well as numerous other inmate names that has completed these programs back on the list and/or through programs taken up needed bed space from other inmates that need these programs or court ordered to take them.

I was moved out of # 10 - dorm and bed asigned in treatment dorm 7 - A two times and forced to take up needed bed space that i was (not) apart of these programs.

My punishment like numerous other inmates here if you dont repeat Mr.Marburns, and/or drug counselor's treatment programs again they conspire together with ventress administrative staff and classification supervisor Mark Bruton retaliating, by refusing to transfer the inmate like myself which has already been approved through montg.,C.R.B.,office. Myself and numerous other inmates here at ventress are just taken up treatment bed space from non - treated prisoners that the warden J.CGile, has prior knowledge of this situation problem and fall to correct by an
