Dear Mr. Swartz:

I'm writing to you as I'm concerned about the health of a possibly innocent man in the Donaldson 'Correctional' facility. Keep in mind as you read this request that Ms. Swiney and attorneys have the absolute proof of his innocence and are just trying to keep Patrick alive until the case comes to court.

While we are waiting, you need to know that Patrick Swiney 154406 G79 needs to see a cardiovascular surgeon immediately for evaluation and treatment for his heart condition. PHS needs to follow the cardiologist's orders from April 2005!

PHS needs to schedule the appointment NOW, as soon as possible, because with 43% of his heart blocked, Mr. Swiney could die and a wrongful death lawsuit will absolutely ensue which will include foreknowledge and intentional neglect!

Since PHS is the medical provider, for the Alabama system, you might want to treat this as an urgent, high-profile situation. PHS would be most wise to schedule an appointment for Mr. Swiney to see the specialist quickly - before he dies in the department's custody.
